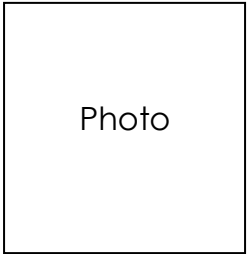

Drivers who have raced continuously may continue up to age 65. New drivers or those returning after a period of absence aged 55 or over will not automatically be issued with a licence. Evidence of fitness will be required from ALL drivers aged 55 or over and at five year intervals thereafter. Drivers aged 16 or 17 will have to provide evidence that they have competed in an approved formula and achieved a high level of competence. They will also have to provide a letter of consent from their parent or guardian giving permission for them to race.
